CIRCULAR

Whereas, in terms of Rule 21 of the Sikkim Municipalities (Conduct of Election) Rules, 2007 the State Election Commission has decided to issue Notification No. 07/SEC/2021, dated 01.03.2021 to conduct the Municipality Election to elect the members from all the Municipal Corporation/Municipal Council and Nagar Panchayat Wards in the state. For conduct of free and fair elections the Model Code of conduct is hereby enforced with effect from 1<sup>st</sup> March, 2021. It is applicable only within the jurisdiction of the Municipal Corporation/Municipal Council and Nagar Panchayats where the elections are going to take place on 31<sup>st</sup> March, 2021 (Wednesday). The Model Code of Conduct will remain enforce till the election process is over.
